How REACH ABH Works

3-Day Virtual Training:

Start by joining us virtually from **December 5-7, 2025**. In these 3 days, you will engage with expert faculty and peers in interactive sessions that equip you with the skills to assess, manage, and treat adult mental health and substance use concerns in a primary care setting.

Bi-Monthly Case-Based Learning Calls:

In the four months that follow this training, you will join twice-monthly calls led by a REACH family physician-psychiatrist faculty team and learn how to manage adult mental health issues based on participants actual cases.

You'll Learn How To...

- ▶ Correctly identify and differentiate among mental health and substance use issues such as anxiety and somatic symptoms, depression, chronic pain, substance abuse, adult ADHD, psychosis, and bipolar disorder
- ▶ Create and implement a comprehensive and effective treatment plan
- ▶ Effectively manage psychopharmacology: select medications, initiate and taper dosages, monitor improvements, and identify and minimize medication side effects
